

CONDITIONS, AGREEMENT AND RELEASE

This agreement is made and entered into by and between the Virginia Numismatic Association and the undersigned ("Applicant Dealer") for bourse booth space at the above-described Convention. The parties hereby agree as follows:

1. The Bourse Chair reserves the right to assign and reassign bourse space at his/her discretion.
2. The bourse booth assigned and the space contained therein cannot be sold, rented, loaned, leased, or subleased without the written consent of the Bourse Chair.
3. Bourse space may be reserved with a deposit of one-half (1/2) the total bourse fees. Bourse fees are due in full by **ALL APPLICATIONS AND TABLE PAYMENTS RECEIVED AFTER JULY 1, 2017 WILL BE ASSESSED AN ADDITIONAL \$25.00 PER TABLE.** Applications may be cancelled in writing and deposit and/or bourse fees refunded at any time prior to July 1, 2017 Refunds for cancellations after August 1, 2017 will be made at the discretion of the Bourse Chair.
4. The Bourse Chair reserves the right to prohibit any items in the bourse area as the Bourse Chair may deem appropriate. Pets, radios, TVs, and weapons are not permitted in the bourse area.
5. Non-numismatic, but related, items will be allowed at the Convention on the following basis: Only one showcase may contain non-numismatic items. All other showcases must contain numismatic items. No dealer may display more than 50% non-numismatic items without prior permission from the Bourse Chair.
6. Only individuals listed on the Bourse Application and wearing official booth holder badges may be permitted behind booth tables.
7. Booth holder badges are not transferable and shall not be loaned or given to others. Violation of this provision may result in suspension of bourse privileges.
8. Each Applicant Dealer may share his table(s) with one additional Share Dealer. The Applicant Dealer assumes all responsibility, financial or otherwise, for all transactions conducted by such Share Dealer and any other persons behind his table and recognizes by signing this application that others will have the right to rely on this representation.
9. Applicants are responsible for having a current Virginia sales tax number and for collecting applicable sales tax.
10. All dealers will be held accountable to the Virginia Numismatic Association Code of Ethics.
11. Security is provided for the convenience of the dealers and attendees. However, there is no insurance carried by the Coin Show, its committees, the sponsoring organizations, nor the convention facility. None of these mentioned parties will be held responsible for any loss, damage, or injury that might be sustained by those assigned space in the bourse, to their employees, or property, from any cause whatsoever, prior to, during, or subsequent to the period covered by this contract.
12. Receipt of this application and payment does not constitute acceptance unless and until countersigned by the Bourse Chair. Signatures of the Applicant Dealer hereto, and acceptance hereof by the Bourse Chair, constitutes the contract within the terms and conditions stated herein.

***13. No Signage or Table Displays (both front and backup) may exceed 30 inches above the standard table surface. But may be above 8 feet off the floor as long as they are safe and secure, to allow clear vision for security looking from aisle to aisle. This does not apply if against the wall. ***

The undersigned applicant is applying for bourse booth or booths and the space contained therein, and if accepted, agrees to the above conditions and hereby releases the Virginia Numismatic Association, the host clubs, and the Fredericksburg Expo and Conference Center and their officers, members, employees, and staff from any liability for loss, damage, or destruction (through negligence, gross negligence, or otherwise) of numismatic or any other material and for personal injury and property damage of any kind.
